

National Truckwash System

About Your Key

You have now purchased a National Truckwash System key which will allow you to access the system locations, receive a regular itemised record of usage and pay a combined account.

To use your key, touch it against the read head on the control panel, then press the ON button for the outlet you wish to use. Remember to press the OFF button when finished, or others may use the system at your expense.

Key Terms and Conditions of Use - (Effective 1 July 2015)

1. These Terms and Conditions replace all previous Terms and Conditions and apply to all new and existing key holders. Avdata may vary these conditions, fees, and charges at any time without notice.
2. Avdata reserves the right to reject key registration applications, including those that are incomplete and/or not signed; or where related accounts have not been paid.
3. The National Truckwash System has been established primarily for the use of livestock transporters. The owner/operator of each separate Truckwash location has the right to set the terms and conditions of use for their facility and all National Truckwash System keys holders are subject to these local requirements. Please contact location/s for details.
4. The purchaser of each key is registered at Avdata as the key holder who is liable for all usage on that key, whether or not the usage was authorised.
5. Avdata must be advised **immediately** on (02) 6262 8111 when a key is reported lost or stolen. This must be followed up with a written advice to Avdata.
6. Upon receipt of such written advice lost or unwanted keys will be de-registered from the Avdata System to prevent unauthorised use.
7. Accounts are issued quarterly, that is: in April for January-March usage; July for April-June usage; October for July-September usage; and in January for October-December usage. Larger accounts are billed monthly.
8. All charges and fees are expressed exclusive of GST with the GST shown separately.
9. Accounts must be paid in full within 21 days of billing, and if not paid by that date, become overdue for payment.
10. A System Access charge of \$6.70 (ex GST) is payable for the January-March quarter. In any following quarter where usage charges have been incurred, a System Access charge will also be generated.
11. A Key Verification charge of \$1.35 (ex GST) per registered key is applied annually on 31 March.
12. A LSRI (Livestock Services Research & Innovations) administration fee may apply to usage charges – 2% of charges (ex GST).
13. Overdue accounts will incur an Overdue Account fee of \$11.25 (ex GST) and will have all of their keys de-registered. Keys will not be re-registered until the account is paid in full. A Key Re-registration fee of \$20 per key (ex GST) may apply. It may take up to 10 days for your access key(s) to be re-registered once your payment has been processed.
14. In the case of overdue accounts the registered key holder is liable for and agrees to pay all legal and other costs and expenses incurred in recovering unpaid amounts.
15. This agreement shall be governed by and construed in accordance with the laws in force in the Australian Capital Territory and be submitted to the exclusive jurisdiction of the courts of that Territory.

Notes

1. Accounts will show the tag number of the key used to operate Truckwashes, minutes of usage, and charge.
2. The description you write on the form will appear against each key. This may be changed by contacting Avdata.
